This waiver and release is intended to be an express waiver of and release from any and all claims against the City of Yonkers, Yonkers Public Schools, and the Yonkers Board of Education and their officials, officers, agents, and employees arising from the activities, including all claims or causes of action based on the alleged negligence or gross negligence of the City of Yonkers, Yonkers Public Schools, and Yonkers Board of Education and their officials, officers, a gents, and employees from all liability and claims to the fullest extent allowed by New York law.

I understand that any camper who does not abide by the rules and regulations set forth by the camp is subject to discussion of dismissal without reimbursement or recourse. No camper will be allowed to leave the campgrounds for any other reason than a medical emergency until the completion of each camp session.
